Resolution was approved with requisite majority.

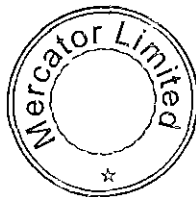

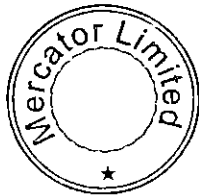

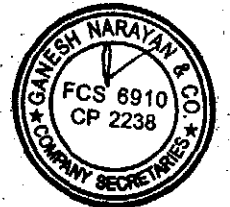
Sub: Scrutinizer's Report on Postal Ballot

- i) Special Resolution approving Issuance of Secured/ Unsecured Non-Convertible Redeemable Debentures (herein after referred to as the "Special Resolution");

I HEREBY SUBMIT MY REPORT AS UNDER:

1. The Company had on May 5, 2018, completed dispatch of the Postal Ballot Notice, along with Explanatory Statement and the Postal Ballot Forms through Registered Post / Courier /E-mail together with details of electronic voting to those Members, whose names appeared in the Register of Members / Records of Depositories as on April 20, 2018.
2. The Company had made arrangement with Central Depository Services (India) Limited (CDSL) for providing electronic voting facilities to all the Members, who were eligible to take part in the voting process.
3. The particulars of all Postal Ballot Forms / details of electronic votes received from Members have been entered in separate Registers maintained for the purpose.
4. All Postal Ballot Forms received / electronic votes casted upto 5:00 p.m. on Monday, June 4, 2018 were considered for my scrutiny. For electronic voting, I have relied on the data of voting made available to me on the (CDSL) portal for the same.

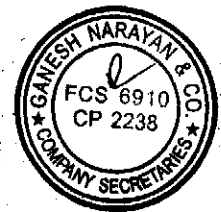

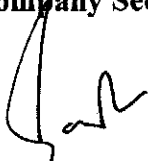

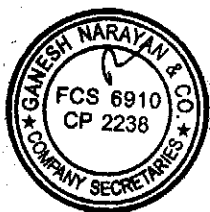
